Specific Notes

- (1) 07DC2502.01(a), Possession of a Destructive Device. The court code refers to a section that refers to both unregistered firearms and destructive devices, and it seems both may be captured here (other rows detail separately destructive device and firearm). Further, to the extent firearms are included here, there is no distinction as to whether the penalty is for first offense (12 months) or with a prior offense (60 months).⁷ As the row appears to potentially include unregistered firearms with a prior offense, the higher 60 month penalty is entered in Column C.
- (2) Unregistered Firearm and 07DC2502.01(a)-X, Possession or Control of a Destructive Device or Unregistered Firearm (Unregistered Firearm). The court code is without distinction as to whether the penalty is for first firearm offense (12 months) or with a prior offense (60 months).⁸ As the row appears to potentially include unregistered firearms with a prior offense, the higher 60 month penalty is entered in Column C.
- (3) 07DC2502.01(a)-Y, Possession or Control of a Destructive Device or Unregistered Firearm (Possession of Destructive Device). As the title of the court code appears to limit the

charge to destructive devices, there is only one applicable maximum penalty of 12 months.

- (4) 07DC2506.01(a), Unlawful Possession of Ammunition. The court code cites to the statute barring possession of ammunition, not the penalties in § 7–2507.06(3) which vary depending on whether there was 1 bullet or more. There is no additional court code that appears to separately address one of the possible penalties. Therefore, the Column C entry reflects the penalty for the aggravated/enhanced version of the offense, 120 months for possessing more than one bullet rather than the 1 year penalty for a single bullet.
- (5) 08DC902, Illegal Disposal of Waste. The court code cites generally to the statute without distinction as to the penalties in paragraphs (b)(2), (b)(3), and (b)(4), which depend on the type of waste at issue and whether the disposal is for a commercial purpose. No other court codes distinguish between the different penalties for the offense. Therefore, Column C reflects the penalty for the most serious version of this offense, 60 months, as opposed to the misdemeanor gradation of the offense (3 months).
- (6) 22DC303, Destruction of Property. The court code cites generally to the statute without distinction as to the penalty when the property has a value of \$1,000 or more (120 months) or when the property has some value (180 days, or 5.9 months). Separate court codes address these two gradations of the offense. Therefore, Column C reflects the penalty for the most serious gradation of the offense, 120 months.
- (7) 22DC401-S, Assault With Intent to Kill, Rob, Commit Sexual Abuse (Third Degree Sexual Abuse). The court code appears to inaccurately refers to 22DC401 because that statute only covers assaults with intent to commit first or second degree sexual abuse. Instead, the best construction of the record seems to be as attempted third degree sexual abuse, so the citations: in Column A should refer to 22DC3004; in Column B should refer to Third degree Sexual Abuse (Attempted); and in Column C should be 60 months. To maintain consistency with the analysis in CCRC Memo #40, these changes were not made at this

- time. However, the corresponding entries in columns D, E, and F are accurate as to the corresponding RCC statute.
- (8) 22DC405A, Resisting Arrest. There currently is no § 22-405A, but the citation appears to refer to the predecessor statute of current 22DC405.01, the resisting arrest statute. Column C reflects the 6 month penalty in D.C. Code 22DC405.01 for resisting arrest
- (9) 22DC801, Burglary. The court code cites generally to the statute without distinction as to the penalty for first degree burglary in subsection (a) (360 months) or the penalty for second degree burglary in subsection (b) (180 months). Separate court codes address first degree burglary in subsection (a) and second degree burglary in subsection (b). Therefore, Column C reflects the penalty for the most serious gradation of the offense, first degree (360 months).
- (10) 22DC811, Contributing to the Delinquency of a Minor. The court code cites generally to the statute without distinction as to the numerous different penalties in paragraphs (b)(1), (b)(2), (b)(3), and (b)(4), which depend on the type of conduct at issue, as well as whether there are prior convictions, or whether serious bodily injury or death resulted. Only one other court code specifies a particular penalty under subsection (b) of the statute, committing the offense with a prior conviction (36 months in paragraph (b)(2)). Therefore, Column C reflects the most serious penalty for the offense, contributing to the delinquency of a minor when death results (120 months in paragraph (b)(5)).
- (11) 22DC811(a)(5), Contributing to the Delinquency of a Minor (Committing a Misdemeanor). The court code cites generally to one type of prohibited conduct in the current D.C. Code statute without distinction as to the numerous different penalties in paragraphs (b)(1), (b)(2), (b)(3), and (b)(4), which depend on the type of conduct at issue, as well as whether there are prior convictions, or whether serious bodily injury or death resulted.¹³ Only one other court code specifies a particular penalty under subsection (b) of

the statute, committing the offense with a prior conviction (36 months in paragraph (b)(2)). Since the offense name that corresponds with the court code 22DC811(a)(5) does not suggest that an enhanced penalty applies, Column C reflects the penalty for least serious version of the offense, 6 months, which does not require a prior conviction or that death or serious bodily injury result (paragraph (b)(1)).

- (12) 22DC902, Trademark Counterfeiting. The court code cites generally to the statute without distinction as to paragraphs (b)(1), (b)(2), and (b)(3), which have different penalties depending on the number of prior convictions, the number of items involved, or the retail value of the items involved. A separate court code specifies the penalty for the least serious version of the offense in paragraph (b)(1). Column C reflects the penalty for the most serious version of the offense, 120 months (paragraph (b)(3)).
- (13) 22DC933, Abuse of a Vulnerable Adult or Elderly Person. The court code cites generally to the statement of elements, not the penalties at § 22–936¹⁵ which vary depending on what type of physical or mental harm, if any, occurred. Separate court codes address two of the three penalties for the offense—the base version of the offense, which encompasses inflicting or threatening physical injury (180 days, or 5.9 months, in subsection (a)), and the intermediate version of the offense, which prohibits inflicting serious bodily injury or severe mental distress (120 months in subsection (b)). No court code appears to address the most serious version of the offense, causing permanent bodily harm or death (240 months in subsection (c)). Column C reflects this most serious penalty, 240 months.
- (14) 22DC933, Abuse of a Vulnerable Adult or Elderly Person (Serious Bodily Injury or Severe Mental Distress). The court code cites generally to the statement of elements, not the penalties at § 22–936¹⁶ which vary depending on what type of physical or mental harm,

if any, occurred. However, the penalty in subsection (b) of 22DC933 is specific to causing serious bodily injury or severe mental distress (120 months) and this is the penalty reflected in Column C.

- (15) 22DC1705, Maintaining Gambling Premises. This statute has an offense-specific repeat offender penalty enhancement¹⁷ that is reflected in the maximum sentence in Column C.
- (16) 22DC1101, Cruelty to Children. The court code cites generally to the statute without distinction as to subsection (a) and paragraph (c)(1), 18 which establish the offense of and penalty for first degree cruelty to children (180 months), and paragraphs (b)(1), (b)(2), and (c)(2), 19 which establish the offense of and penalty for second degree cruelty to children (120 months). Separate court codes address the different penalties for first degree and second degree child cruelty. Therefore, Column C reflects the penalty for the most serious version of the offense, 180 months.
- (17) 22DC1805a, Conspiracy to Commit a Crime. The court code cites generally to the statute²⁰ without distinction as to paragraph (a)(1) and paragraph (a)(2), which have different penalties depending on the target offense—60 months, unless the target offense has a maximum term of imprisonment of less than 5 years, in which case the penalty is the maximum penalty for the target offense (paragraph (a)(1)), or 180 months, if the target offense is a "crime of violence" (paragraph (a)(2)). Separate court codes address the different penalties in paragraphs (a)(1) and (a)(2) of 22DC1805a. Therefore, Column C reflects the penalty for the most serious version of the offense, 180 months.

Therefore, the Column C entry reflects the penalty for the most aggravated/enhanced version of the offense, 120 months for Class A contraband.
- (21) 22DC2603.02, Unlawful Possession of Contraband in Penal Institution.

- (24) 22DC2701, Prostitution or Solicitation for Prostitution (Solicitation). The court code cites generally to the statute without distinction as to subparagraph (b)(1)(A) and subparagraph (b)(1)(B),²⁴ which have different penalties depending on the number of prior convictions— 3 months for a first offense (subparagraph (b)(1)(A)) and 180 days, or 5.9 months, for a second offense (subparagraph (b)(1)(B)). A separate court code addresses the penalty in paragraph (b)(2) for a third or subsequent offense (24 months). The Column C entry reflects the penalty for a second offense, 180 days, or 5.9 months.

- (27) 22DC2706, Detaining or Compelling to Reside for Prostitution. The court code cites generally to the statute without distinction as to paragraphs (b)(1) and (b)(2),²⁶ which have different penalties depending on the age of the person detained or compelled—60 months if the person is 18 years of age or older (paragraph (b)(1)) and 240 months if the person is under 18 years of age (paragraph (b)(2)). No other court code distinguishes between paragraphs (b)(1) and (b)(2) of 22DC2706. Therefore, the Column C entry reflects the penalty for the most serious version of the offense, 240 months.
- (28) 22DC2707, Arranging for or Compelling Prostitution. The court code cites generally to the statute without distinction as to paragraphs (b)(1) and (b)(2),²⁷ which have different penalties depending on the age of the person arranged for or compelled to engage in prostitution—60 months if the person is 18 years of age or older (paragraph (b)(1)) and 240 months if the person is under 18 years of age (paragraph (b)(2)). No other court code distinguishes between paragraphs (b)(1) and (b)(2) of 22DC2707. Therefore, the Column C entry reflects the penalty for the most serious version of the offense, 240 months.

The court code cites to the statute for first degree sexual abuse of a secondary education student, but the offense name does not specify first degree. Code § 22-2707(b) ("(b)(1) Except as provided in paragraph (2) of this subsection, a person who violates subsection (a) of this section shall be guilty of a felony and, upon conviction, shall be punished by imprisonment for not more than 5 years or by a fine of not more than the amount set forth in § 22-3571.01, or both. (2) A person who violates subsection (a) of this section when the individual so arranged for or caused to engage in prostitution or a sexual act or contact is under the age of 18 years shall be guilty of a felony and, upon conviction, shall be punished by imprisonment for not more than 20 years or by a fine of not more than the amount set forth in § 22-3571.01, or both.").

- (30) 22DC4014, Failure to Register As Sex Offender. The court code cites generally to the registration requirement statute, not the penalties at § 22–4015 (a) which vary depending on whether there was a prior conviction.²⁸ There is no additional court code that appears to separately address one of the possible penalties. Therefore, the Column C entry reflects the penalty for the aggravated/enhanced version of the offense, 60 months for having a prior conviction rather than 5.9 months (180 days) for a first offense.
- (31) 22DC3133, Stalking. The court code cites generally to the statement of elements, not the penalties at § 22–3134 which vary depending on whether there was one or more prior convictions or other aggravating factors.²⁹ There are additional court codes that appears to separately address felony and misdemeanor penalties, leaving it ambiguous what is covered by this row. Therefore, the Column C entry reflects the penalty for the most aggravated/enhanced version of the offense, 120 months for having two or more prior convictions.
- (32) 22DC3133(a)(1), Stalking (With Intent to Cause Fear or Distress).
 - o Identical to immediately above.
- (33) 22DC3133(a)(2), Stalking (Knowing Will Cause Fear or Distress).
 - o Identical to immediately above.
- (34) 22DC3133(a)(3), Stalking (Should Know Will Cause Fear or Distress).
 - o Identical to immediately above.
- (35) 22DC3133-F, Stalking.
 - o Identical to immediately above (ambiguous as to which felony penalty).
- (36) 22DC3223(d)(1), Credit Card Fraud (Felony). There appears to be a court error here as 22DC3223(d)(1) is the misdemeanor penalty provision, while (d)(2) is the felony provision, yet the former has felony penalties while the latter is limited to misdemeanor penalties.³⁰ Consistent with CCRC Research Memo #40, the citation in Column A has not

been changed, but the entries in Columns B-F correctly reflect the felony/misdemeanor nature of the court records and their corresponding RCC offenses.

- (37) 22DC3223(d)(2), Credit Card Fraud (Misdemeanor).
 - o Identical to immediately above.
- (38) 22DC3242, Forgery. The court code cites generally to the statute without distinction as to the subsections, which have different penalties depending on the type of document at issue—120 months (for documents listed in subsection (a)),³¹ 60 months (for documents listed in subsection (b)),³² or 36 months (for other unlisted documents in subsection (c)).³³ There is a court code that separately addresses the penalty in subsection (c) for unlisted documents, 22DC3242(c), but no court code appears to distinguish between subsection (a) and subsection (b). Therefore, the Column C entry reflects the penalty for the most serious version of the offense, 120 months.
- (39) 22DC3242, Forgery (Uttering).
 - o Identical to immediately above.
- (40) 22DC3302, Unlawful Entry. The court code cites generally to the statute without distinction as to the subsections which have different penalties depending on whether the property is a public building (6 months)³⁴ or otherwise (5.9 months).³⁵ There is no additional court code that appears to separately address one of the possible penalties. Therefore, the Column C entry reflects the penalty for the aggravated/enhanced version of the offense, 6 months.
- (41) 22DC4504(a), Carrying Dangerous Weapon (Rifle or Shotgun) (Outside home or business). The court code appears to inaccurately refer to subsection (a) of 22DC4504. Paragraph (a)(1) of 22DC4504 codifies the penalty for carrying a rifle or shotgun³⁶ outside the home or place of business (60 months). Subsection (a) codifies the penalty (12 months under D.C. Code § 22-4515) for carrying a rifle or shotgun if the penalties in paragraph (a)(1) and paragraph (a)(2) do not apply. Because the offense name is specific to "outside home or business" and paragraph (a)(1) falls under subsection (a), Column C includes uses the 60 months penalty.
- (42) 22DC4504(a)-F, Carrying Dangerous Weapon. The court code cites generally to subsection (a), which contains the misdemeanor penalty for the offense (12 months under D.C. Code § 22-4515). Paragraph (a)(1) of 22DC4504 codifies the felony penalty for carrying a dangerous weapon outside the home or business (60 months). However, the court data indicates penalties greater than 12 months for 22DC4504(a)-F and there is a

- separate court code for misdemeanor carrying a dangerous weapon under subsection (a) of 22DC4504. Therefore, Column C reflects the penalty for the felony offense (60 months).
- (43) 22DC4504(a)-Y, Carrying Dangerous Weapon Without A License (Outside home or business). The court code appears to inaccurately refer to subsection (a) of 22DC4504. Paragraph (a)(1) of 22DC4504 codifies the penalty for carrying a dangerous weapon outside the home or place of business (60 months). Subsection (a) codifies the penalty (12 months under D.C. Code § 22-4515) for carrying a dangerous weapon if the penalties in paragraph (a)(1) and paragraph (a)(2) do not apply. Because the offense name is specific to "outside home or business" and paragraph (a)(1) falls under subsection (a), Column C includes uses the 60 months penalty.
- (44) 22DC4504(a)-Z, Carrying Dangerous Weapon Without A License (Outside home or business). The court code appears to inaccurately refer to subsection (a) of 22DC4504. Paragraph (a)(1) of 22DC4504 codifies the penalty for carrying a dangerous weapon outside the home or place of business (60 months). Subsection (a) codifies the penalty (12 months under D.C. Code § 22-4515) for carrying a dangerous weapon if the penalties in paragraph (a)(1) and paragraph (a)(2) do not apply. Because the offense name is specific to "outside home or business" and paragraph (a)(1) falls under subsection (a), Column C includes uses the 60 months penalty.
- (45) 22DC4515a(a), Manufacture, Transfer, Possession, or Use of an Explosive (Possession of a Molotov Cocktail). This statute has an offense-specific repeat offender penalty enhancement³⁷ that is reflected in the maximum sentence in Column C.
- (46) 23DC585(b), Failure to Appear for Citation Release. The court code cites generally to the statute subsection without distinction as to the subparagraphs which have different penalties depending on whether the release is for a misdemeanor (max of the penalty available for the misdemeanor on which was released) or a felony (60 months). There are additional court codes that appear to separately address both of the possible penalties, this undifferentiated code is ambiguous. Therefore, the Column C entry reflects the penalty for the aggravated/enhanced version of the offense, 60 months.
- (47) 48DC904.01(a)(1)-X, Controlled Substance Possession With Intent to Distribute. The court code cites generally to paragraph (a)(1) without distinction as to the penalties in paragraph (a)(2) and its subparagraphs, which have different penalties depending on the Schedule of the controlled substance at issue. Therefore, Column C reflects the penalties for the most serious version of the offense in subparagraph (d)(2)(A).
- (48) 48DC904.01(a)(1)-Y, Controlled Substance Distribution. The court code cites generally to paragraph (a)(1) without distinction as to the penalties in paragraph (a)(2) and its subparagraphs, which have different penalties depending on the Schedule of the controlled substance at issue. Only one court code cites to a subparagraph with a specific penalty, 48DC904.01(a)(1)(2)(D), Controlled Substance Distribution (Schedule V). Therefore, Column C reflects the penalties for the most serious version of the offense in subparagraph (d)(2)(A).

- (49) 48DC904.01(a)(1)-Z, Controlled Substance Manufacture or Possessing W/Intent to Manufacture. The court code cites generally to paragraph (a)(1) without distinction as to the penalties in paragraph (a)(2) and its subparagraphs, which have different penalties depending on the Schedule of the controlled substance at issue. Therefore, Column C reflects the penalties for the most serious version of the offense in subparagraph (d)(2)(A)
- (50) 48DC904.01(b)(1), Counterfeit Controlled Substance Distribution. The court code cites generally to paragraph (b)(1) without distinction as to paragraph (b)(2) and its subparagraphs, which have different penalties depending on the Schedule of the controlled substance at issue. Therefore, Column C reflects the penalties for the most serious version of the offense in subparagraph (b)(2)(A).
- (51) 48DC904.06, Controlled Substance Distribution to a Minor. The court code cites generally to the statute without distinction as to subsection (a) or subsection (b), which have different penalties depending largely on the Schedule of the controlled substance at issue. Therefore, Column C reflects the penalties for the more serious version of the offense in subsection (a).
- (52) 48DC1103(b), Drug Paraphernalia Delivery, Sale, or Possession With Intent to Distribute (Possession With Intent to Distribute). This statute has an offense-specific repeat offender penalty enhancement that is reflected in the maximum sentence in Column C.
- (53) 50DC2201.04(b), Reckless Driving. This statute has an offense-specific repeat offender penalty enhancement that is reflected in the maximum sentence in Column C.
- (54) 50DC2201.04(b-1)(1), Aggravated Reckless Driving (Speed). This statute has an offense-specific repeat offender penalty enhancement that is reflected in the maximum sentence in Column C.
- (55) 50DC2201.05b(b), Failure to Stop or Fleeing Officer in a Motor Vehicle. The court code cites generally to the statute subsection without distinction as to the paragraphs, which have different penalties. Paragraph (b)(1) specifies a penalty of 180 days, or 5.9 months. Paragraph (b)(2) specifies a penalty of 60 months if the operator of the motor vehicle drives in a reckless manner or causes property damage or bodily injury (paragraph (b)(2) with a maximum penalty of 60 months. There are additional court codes that appear to separately address both of the possible penalties, this undifferentiated code is ambiguous. Therefore, the Column C entry reflects the penalty for the aggravated/enhanced version of the offense, 60 months.
- (56) 50DC2201.05c(a)(1), Leaving After Vehicle Collision (Personal Injury). This statute has an offense-specific repeat offender penalty enhancement that is reflected in the maximum sentence in Column C.
- (57) 50DC2201.05c(a)(2), Leaving After Vehicle Collision (Personal Injury). The court code appears to inaccurately refer to paragraph (a)(2) of 50DC2201. Paragraph (a)(2) of 50DC2201 is limited to property damage or injury to a domestic animal. Paragraph (a)(1) of 50DC2201 requires personal injury. Because another court code correctly cites to paragraph (a)(1) for "Leaving After Vehicle Collision (Personal Injury)," Column C in Row 332 includes penalty information for paragraph (a)(2) of 50DC2201. This statute also has an offense-specific repeat offender penalty enhancement that is reflected in the maximum sentence in Column C.

- (58) 50DC2206.13, Operating a Vehicle Under the Influence of Alcohol or a Drug. The court code cites generally to the statute without distinction as to subsections (a), (b), (c), and (d), which have different penalties depending on the number of prior convictions and the person's alcohol or drug concentration. A separate court code specifies the penalty for the least serious version of the offense in subsection (a), a first offense. Therefore, Column C reflects the penalty for the most serious version of the offense, 12 months (subsection (c)), for two or more prior convictions. The most serious version of the offense has additional mandatory minimums depending on the person's alcohol or drug concentration.³⁸ Column D reflects that the mandatory minimum penalty for this most serious version of the offense "is .5 1.5" months.
- (59) 50DC2206.13(a), Operating a Vehicle Under the Influence of Alcohol or a Drug (First offense); 50DC2206.13(a), Operating a Vehicle While Intoxicated (First Offense). The court code specifies the penalty for the least serious version of the offense in subsection (a) for a first offense, 5.9 months (180 days). The most serious version of the offense has mandatory minimums depending on the person's alcohol or drug concentration.³⁹ Column D reflects that the mandatory minimum penalty for this most serious version of the offense "is .3 .6" months.
