This Draft Report contains recommended reforms to District of Columbia criminal statutes for review by the D.C. Criminal Code Reform Commission's statutorily designated Advisory Group. A copy of this document and a list of the current Advisory Group members may be viewed on the website of the D.C. Criminal Code Reform Commission at www.ccrc.dc.gov.

Any Advisory Group member may submit written comments on any aspect of this Draft Report to the D.C. Criminal Code Reform Commission. The Commission will consider all written comments that are timely received from Advisory Group members. Additional versions of this Draft Report may be issued for Advisory Group review, depending on the nature and extent of the Advisory Group's written comments. The D.C. Criminal Code Reform Commission's final recommendations to the Council and Mayor for comprehensive criminal code reform will be based on the Advisory Group's timely written comments and approved by a majority of the Advisory Group's voting members.

The deadline for the Advisory Group's written comments on this Second Draft of Report #41, *Ordinal Ranking of Maximum Imprisonment Penalties*, is Wednesday, April 15, 2020 (8 weeks). Oral comments and written comments received after this date may not be reflected in the next draft or final recommendations. All written comments received from Advisory Group members will be made publicly available and provided to the Council on an annual basis.

This report presents for Advisory Group comment a second draft of recommendations for the ordinal ranking of the maximum imprisonment penalties for RCC offenses. This is a critical step toward developing recommendations for proportionate imprisonment penalties.¹

These draft recommendations are presented in the form of a spreadsheet, below. Rows of the sheet present discrete RCC offenses, offense gradations and offense-specific enhancements. Every RCC offense drafted to-date is listed, by RCC citation and name. Columns of the sheet present, besides the RCC citation and name, a classification and a graphical display of that classification. Classifications range from 1-9 for felonies (over 1 year) and A-E for misdemeanors (1 year or less). For convenience of review, one sheet of the spreadsheet is ordered by the RCC citation, a second sheet of the same data is ordered by the proposed class. Yellow highlighting indicates new classifications since the first draft, either because the offenses/gradations are altogether new since the first draft or because the CCRC has amended the prior recommendation in the first draft. Where a prior recommendation in the first draft has been amended, orange highlighting denotes the first draft (prior) ranking.

Like the First Draft of Report #41, the present report contains two models of possible absolute maximum imprisonment penalties for statutory penalties. These models are an aid to evaluation of the relative rankings only. A new report with a CCRC recommendation about absolute maximums and minimum penalties, mandatory and statutory, will be issued in the near future (mid-March), prior to the time that written comments are due on this report.

Unlike the First Draft of Report #41, the present report does not contain separate notations for which offenses are jury demandable. A new report with a CCRC recommendation about jury demandability will be issued in the near future (less than two weeks), prior to the time that written comments are due on this report.

Please assume offense elements are the same as in the latest RCC draft recommendations when providing comments on this report. See First Draft of Report #50, Cumulative Update to the Revised Criminal Code (February 19, 2020). The CCRC appreciates that developing such recommendations requires consideration of a large and complex number of considerations about the overall RCC and sentencing considerations, and that other aspects of the RCC are still subject to change. Nonetheless, assessing the relative severity of RCC offenses as currently drafted is a discrete, achievable, very useful step toward developing final recommendations on penalties.

Comments may be made separately on this report (ordinal ranking of penalty classes) and the forthcoming report on absolute numbers for penalty classes, or comments

on the penalty for specific offenses may be made as a combination of the class and the punishment for that class. However, to the extent that the latter approach is taken, comments are particularly welcome on how the penalty for a specific offense should compare to other offenses.

<u>Please explain the basis of any changes that are suggested in comments on this report</u>. Under separate cover, the CCRC has provided various data sources that you may wish to consider as part of your review and may provide evidence in support of your comments. See: Advisory Group Memo #26 – DC Code Statutory Penalties and Voluntary Sentencing Guidelines; Advisory Group Memo #27 – Public Opinion Surveys on Ordinal Ranking of Offenses; and Advisory Group Memorandum #28 - Statistics on District Adult Criminal Charges and Convictions. However, the CCRC would particularly welcome other data (e.g. particular District cases) that may aid the agency's efforts to evaluate proportionality.

CCRC Responses to Advisory Group comments on the First Draft of Report #41 (Oct. 3, 2019) have been included in Appendix D1 to the First Draft of Report #50, Cumulative Update to the Revised Criminal Code (February 19, 2020).

Time permitting, in the coming months the CCRC plans to issue commentary regarding key penalty classifications in this report.
